



CHIEF EXECUTIVE OFFICER

Dr. Megan Selman, Chamber and Economic Development Alliance CEO, is responsible for economic development in Russellville and the regional area, overseeing Chamber & Alliance staff and functions, and working with community leaders to enhance economic stability and drive community progress. Megan serves as the liaison to the Chamber Board of Directors, the Alliance Board of Directors, the Joint Officers Committee, the Russellville Development Foundation, and the Industrial Site Selection Committee. We began 2023 with an announcement from Owens Corning committing to a \$60 million dollar capital investment in Russellville with a new foam insulation plant in our East End Industrial Park. With this investment, new high paying jobs will be added to our community and a new and innovated product will be produced right here in Russellville.

Additionally, in 2023 the Chamber and Alliance hosted 8 site visits for industries and large-scale developments looking at the Russellville area for their next project. Many of these projects are ongoing and we look forward to more success and exciting announcements in 2024.

The Russellville Alliance for Economic Development was recognized for it's accomplishments by Governor Hutchinson during his 2022 Proclamation of Economic Development Week, and in 2023 by Governor Sanders as she acknowledged the economic development happening at Chambers across the state.

ECONOMIC DEVELOPMENT

AEDC featured Russellville in several publications throughout the year. Additionally, the Alliance was featured on the AEDC round table podcast in 2023, alongside only 2 other economic development organizations in Arkansas. In 2023, Selman was awarded Economic Development Rockstar by Southern Business and Development, an award only given to 3 economic developers in the state annually.

In 2023 the Alliance, with AEDC and Entergy Arkansas, Re-Certified a 45-acre industrial site in order to be one of few communities across the state to boast a Select Site piece of industrial property. We also formed a Site Selection committee to aggressively purpose new industrial property that we can have packaged and ready to go (available

product) in order to compete for projects on a large scale.

At the request of local industry and area employers, the Alliance conducted a wage and benefit surveyed to reflect the most recent information in our labor market. We also surveyed local industries to assess strengths, challenges, and current state of industrial/manufacturing climate in Russellville for our largest employers.





The Alliance worked with multiple local and state agencies to bring opportunity and increased prosperity to our region. In a time with rising interest rates, inflation, supply chain disruptions, and labor shortages, Russellville and the surrounding area continues to work hard, defy the odds, and succeed in growing the local economy. We worked to tell a better story to recruit business and industry as well, with 4 new commercials and multiple aggressive marketing strategies to ensure Russellville and our regional community continue to compete on a national scale.



COMMUNITY DEVELOPMENT

A successful Bash at the Ballpark was held at Baswell Baseball Field on the campus of ATU. The ATU Connect Committee organized the annual event with games, team autographs, giveaways, food and lots of fun.

The ATU Connection Council organized the 8th Annual Paint the Town Green & Gold held August 14-22. Thirty-six businesses participated in the decorating contest with winners announced at the first home football game. C&D Drug Store of Russellville earned the top overall prize in the 2023 Paint the Town Green and Gold Additional winning businesses and organizations included Boys and Girls Clubs of the Arkansas River Valley-Russellville (best outdoor display), Jean's Simple Treats and More (best first-time entry), Baptist Health Urgent Care-Weir Road (best indoor display), The Gunslingin' Burger (Tech pride), JBT Corporation and Friendship Pottery Worx (co-winners, best Jerry the Bulldog) and JBT Corporation (people's choice).

This event and Bash at the Ballpark bring business partners together to support Arkansas Tech.











COMMUNITY DEVELOPMENT

Our annual First Responder Appreciation Cookout was a huge success this year. We served over 300 meals on Sept 11, as we gathered at Depot Park to honor our local heroes. We can not thank them enough for all they do for us each day. We had great food, live music, and tons of volunteers for this event.



In 2023 the City of Russellville was awarded \$24 million to expand the Russellville Connected Trails System. The Chamber of Commerce served on the advisory board for the grant and helped gather business, government, and community letters of support for the project.

Each year, the Chamber of Commerce works with River Valley United Voices to honor 3 inductees into the River Valley Black Hall of Fame. This esteemed institution honors and commemorates the significant contributions and achievements of individuals in various fields such as arts, sports, politics, and community leadership, highlighting their profound impact on our community. The award serves as a symbol of recognition and celebration, aiming to inspire future generations.



Inspire River Valley expanded in the past school year, with volunteer guest speakers from 16 regional companies giving presentations to over 1,000 students and individuals in the





WORKFORCE DEVELOPMENT

Connecting Educators with Industry was held in summer 2023. Sixty area educators toured International Paper, and Bridgestone-Firestone. After the tours, there was a lunch and a panel discussion from local industry leaders. Educators were then given the opportunity to tour the Be Pro Be Proud mobile demonstration unit. The fifth annual Skilled Trade Expo brought 28 schools from 7 counties, with 2,300 students to

schools from 7 counties, with 2,300 students to Cyclone Arena in October. Over forty employers and trade schools exhibited in advanced manufacturing, healthcare, military and law enforcement, logistics & transportation, automotive technology, cosmetology, construction, utilities, agriculture, heavy equipment operation, and other career fields. Approximately seventy volunteers made this event possible, including a large group of area bankers who served as guides.

To celebrate National Manufacturing Day in 2023, a new event focusing on 7th and 8th grade students who are interested in technology, automation, and engineering was held, "Connecting Students with Technology". 25 students from Dardanelle and 25 students from Russellville toured the Rockline Industries facility and heard from some local industry leaders about the technologies used by their companies.

GOVERNMENT AFFAIRS

In February a legislative reception was held in February for the 94th Annual General Assembly. A record crowd attended the event. The reception was held at Red & Blue Events Venue adjacent from the state capitol. Russellville business leadership had the opportunity to meet elected officials and public policy decision makers in person.

US Representative Bruce Westerman held a meet and greet and shared a legislative update on February 16 at the Chamber office.

Members of the Chamber staff and community members attended the 63rd annual Arkansas State Chamber Washington Fly-In May 10-12 in Washington DC. A reception was held honoring the Chiefs of Staff, legislative directors and schedulers. Meetings included a working breakfast with Arkansas House Delegation, policy briefings and a national economic outlook update, along with a working lunch with the Arkansas Senate Delegation. Private meetings with US Representative Bruce Westerman and US Senator John Boozman's staff also took place. Congressman Bruce Westerman also took the group on a private night tour of the US Capitol.

In a year marked by dynamic business and networking opportunities, the 20th annual River Valley Business Expo marked a significant milestone in our community's economic development journey. In 2023, two pivotal annual meetings were held, each serving as a testament to the Chamber and Alliance's dedication to progress and excellence. The January gathering encapsulated the successes of 2022, featuring an insightful keynote address by Ted Abernathy of Economic Leadership, LLC who delved into the impending workforce challenges facing the upcoming generation and labor pool. 2023 culminated with a December meeting, highlighting the achievements of the year. Both annual meetings hosted the installment of new board officers and recognition of notable honorees including the Red Coat Ambassador

of the Year and the Citizen of the Year. The 2023 meeting welcomed esteemed guests, Jacob Oliva, the Arkansas Secretary of Education, and Arkansas' Chief Workforce Officer Mike Rogers, who addressed transformative changes in the state's educational and workforce landscape, emphasizing initiatives aimed at bolstering future prospects for all. These meetings stand as beacons of achievement and innovation, propelling the local community towards a promising future.

- In 2023, Russellville was selected as a pilot community in the Society for Human Resource Management (SHRM) National Foundation's Employment Accessibility project.
- The Chamber created a committee of non-profit, employers, and community organizations that represent traditionally underserved populations. The committee was challenged with designing a program to address the local employment issues.
- A plan to create interactive kiosks, that would display web-based information about job openings and job resources was developed. A local event for Human Resources and a marketing campaign would promote the kiosks, and the website.

- SHRM awarded a grant of \$75,000 to the Russellville Chamber's Employment Accessibility committee for their project, which will be implemented in 2024.
- In October, the Chamber applied as lead organization for an EDA Recompete Phase I Strategy Development Grant that would fund additional studies to support a local workforce training center.
- As part of EDA Recompete, the Chamber submitted a workforce training center plan proposal. If accepted, we will qualify to apply for a Phase II implementation grant in 2024. Implementation grants in the range of \$50 million will be funded on a regional basis.

We remain focused on membership recruitment and retention through direct, face-to-face interactions. 
Red Coat Mission Statement

Class 37 Project

This year's class, Class 37, decided to improve the downtown flagpole by installing an automated winch system as part of their community project. This simplifies and ensures the safety of lowering and changing out the American flag. On May 25th, improvements were made to the flagpole island such as landscaping, power washing, and repainting. They were also able to purchase a supply of flags to help replenish the inventory that have been purchased by a private donor for two decades. Updates to the flagpole island included new landscaping, power washing and paint.
